

PHOENIX FLAG FOOTBALL LEAGUE (PFFL)

WAIVER, RELEASE OF LIABILITY & RULES ACKNOWLEDGMENT AGREEMENT

League Organizer: Phoenix Flag Football League (PFFL), operated by Phoenix Performance Solutions, Inc.

Primary Facility: Green Hill High School, Mt. Juliet, TN (subject to change based on location availability. Other facilities will be within the Middle, TN area)

By participating in the Phoenix Flag Football League, I acknowledge and agree to the following:

1. ASSUMPTION OF RISK

I understand that flag football is a physical sport involving running, cutting, jumping, rapid directional changes, collisions, and accidental contact. Participation may result in serious injury, including but not limited to:

- Sprains, strains, and muscle tears
- Concussions or head injuries
- Joint injuries (knees, ankles, shoulders, etc.)
- Broken bones
- Heat-related illness
- Cardiac events
- In rare cases, permanent disability or death

I voluntarily choose to participate with full knowledge of these risks and certify that I am physically capable of doing so.

2. RELEASE OF LIABILITY & HOLD HARMLESS

In consideration for being allowed to participate, I **release and hold harmless** the following parties from all liability, claims, damages, or causes of action arising from participation:

- Phoenix Flag Football League (PFFL)
- Phoenix Performance Solutions, Inc.
- All referees, statisticians, volunteers, and contractors

- All league officials and employees
- Green Hill High School, its administrators, staff, and affiliates
- Any facility owners or field partners
- All sponsors, vendors, and partnered businesses

This release applies to injuries or damages arising from ordinary negligence but does not apply to gross negligence or intentional misconduct.

I agree to indemnify PFFL and its partners against any claims brought by myself, my family, my estate, or any third party resulting from my participation.

3. MEDICAL TREATMENT & INSURANCE

I understand that PFFL does **not** provide medical or accident insurance.
I agree that:

- I am solely responsible for my medical coverage and expenses.
- In the event of injury or emergency, PFFL staff may seek medical care on my behalf and I am responsible for all associated costs.

4. RULES ACKNOWLEDGMENT & CONDUCT POLICY

I acknowledge that I have access to the full **PFFL Rules Book** and agree to follow all league rules, including but not limited to:

- Equipment and uniform requirements (e.g., **pocketless shorts**, proper flags)
- Player eligibility and roster rules
- Sportsmanship and conduct standards
- Respecting referees and accepting their decisions
- Safety-related rules (no tackling, no dangerous contact, no illegal equipment)

I understand that:

- The league may issue penalties, suspensions, or removal without refund for violations.
- Threats, fighting, abusive language, harassment, or unsafe behavior may result in immediate ejection and potential season-long or permanent suspension.

5. SCHEDULING & SEASON EXPECTATIONS

I understand and agree:

- PFFL will **attempt** to accommodate reasonable scheduling requests, but **cannot guarantee** any specific time slots, matchups, or field assignments.
 - Games may be delayed, rescheduled, or canceled due to weather, field availability, or operational needs.
 - Registration is for the *season as a whole*, not guaranteed individual game times.

6. PAYMENT DEADLINE & REMOVAL POLICY

I understand and agree to the following mandatory payment terms:

- **All player fees must be paid in full before my first scheduled game.**
- If fees are not paid by Game 1, I may be **removed from the roster** and deemed **ineligible to participate**.
- If removed for non-payment, **I will not receive a refund, credit, or prorated adjustment.**

This policy applies regardless of participation, attendance, or personal schedule conflicts.

7. MEDIA, RECORDING & USE OF LIKENESS

I acknowledge and agree that PFFL:

- Uses multiple cameras, including AI/stat-tracking systems, to record games and sideline footage.
- May capture photographs, videos, audio, and performance statistics.

By participating, I grant PFFL the **irrevocable right** to use my:

- Name
- Image
- Voice
- Jersey number
- Video/photographic likeness
- Game statistics

...for marketing, promotional use, highlights, social media, livestreams, advertisements, and league branding.

This may occur **without compensation**, and all media becomes property of PFFL.

8. STATS, TECHNOLOGY & LIMITATIONS

I understand and accept that:

- PFFL will make a good-faith effort to track and publish accurate stats.
- Camera or software failures may occur.
- Stats may be incomplete, delayed, or unavailable during technical issues.
- Final stats are determined by league administrators and may not be disputed.

I acknowledge that **stats are a courtesy, not a guaranteed deliverable**.

9. VOLUNTEERS & GAME-DAY SUPPORT

I understand that PFFL may occasionally need volunteers to help with:

- Filming
- Spotting player numbers
- Tracking basic stats
- Setting up or breaking down equipment

If I choose to volunteer, I do so at my own risk, and the same waiver and release apply.

10. AGREEMENT, GOVERNING LAW & ELECTRONIC SIGNATURE

I agree that:

- This waiver is governed by Tennessee law.
- If any portion is found unenforceable, the remaining sections remain valid.
- My acknowledgment on the registration form serves as my **electronic signature**, legally binding me to all terms herein.
